Tanfac Industries (BSE: TANFAC), one of India's leading Specialty fluoride chemical manufacturers has approved the proposal to carry out the expansion of the existing capacity of Hydrofluoric Acid Plant at Cuddalore by 14,850 MT per annum to 29,700 MT per annum. This will be a brownfield expansion in its existing unit.

Speaking about the expansion plan, K. Sendhil Naathan, Managing Director of Tanfac Industries, said, "We are excited to announce that we have planned to increase our HF capacity in view of high demand. Once commissioned, this will become one of the largest HF plants in India. We intend to use majority of HF to manufacture high-end specialty fluoride molecules within our group companies. This expansion will sustain our growth trajectory going forward. This capex will be on stream in the next 15 to 18 months."
